¿Where do we come from?

Profession that emerged in the nineteenth century

1930s - First non-university studies in Social Work



1950s -First Social Assistance services and appearance of the first professional associations of Social Workers

1967 - Spanish Federation of Associations of Social Workers emerges

1977 - Law of constitution of the special National Corps of Social Assistants



¿De dónde venimos?

1980 y 1981 – Creation of the university degree of Social Work in University Schools

1982 - Creation of the Regional Professional Bodies, the Regional Councils and the General Council of Social Work by Law



1983 - Degree in Social Work (3 years)



2008 - Degree in Social Work (4 years), appearance of Master and Doctorate



Social Work profession today

Regulated profession with University Degree

Important relationship between the University and professional organizations

To practice in any sector in Spain it is mandatory to have an University degree in Social Work (or equivalent) and be registered in a Professional Body (established by law and recognized by the European Commission)

Professionals from outside Spain must meet the same requirements through the recognition of qualifications (depending on their origin)

Social workers are reference professionals in Public System of Social Services

¿Who are we? Our Organization

General Council of Social Work

Public entity constituted by Public Law, acting as a representative, coordinating and executive body of the 36 Professional Bodies of Social Work and two Regional Councils

More than 36.000 members



The governing bodies are the General Assembly composed of the 36 Professional Bodies, the Executive Board and the Presidency

Our Bylaws are approved by Royal Decree by the Ministry of Social Rights and Agenda 2030

Among our functions are ordering of the professional exercise of social workers, offering advocacy on behalf of the profession, ensuring the prestige of the profession and the fulfillment of its deontological duties, in addition to international representation and defense fundamental rights of citizens.

- ✓ Fulfill the function of citizens' service.








The importance of our Code of Ethics

First Code adopted in 1999 and updated in 2012

It confirms the commitment of the social work profession with society, including scientific-technical improvements and the development of new rights and responsibilities of both the social worker and users.

It reflects the roles, principles, instruments, rights and duties to be known by the social worker

Translated into all regional languages and English.





Publications




